Council Highlights

November 9th

- New Member list was presented.
- Atrium/Elevator progress was discussed.
We have withdrawn the total amount of the loan which is \$1.75 million. We are currently making monthly interest only payments.
- Recarpeting of the Nave and completion of the wood flooring will cost \$13,000. Hoping for completion by Christmas.
- When the heating system was turned on, another leak started. Dual Temp has been on site making repairs.
- Comfort height toilets have been requested for our restrooms. Two will be installed.
- Council approved matching funds of two large donations of \$1,000. Money will be distributed to New Bethany and local food banks to help with the current food deficit they are experiencing.

Pantry Sunday

Food donations collected in the month of December will go to Northeast Community Center's food pantry. They operate nine times per month in the Marvine-Pembroke neighborhood, serving an average of over 300 families per day. Items they especially need: 1lb bags of rice, beans, cooking oil, pasta, pasta sauce, canned meats, cereal, canned fruit and vegetables, coffee, tea, bottled drinks.
